



In the event of acceptance of Tender, the successful bidder shall be required to deposit full amount in the shape of Demand Draft (DD)drawn in favour of the **Principal**, **IGIPESS**payable at New Delhi within 04 days from the issue of order, failing which the sale order shall be cancelled and EMD will be forfeited.
