## AWARD OF THE" VEENA DUA MEMORIAL SCHOLARSHIP"

The proposal made by Mrs. Vidyawati Saighal, 38, Babar Road, New Delhi-110001, for instituting a scholarship in the memory of her daughter late (Ms.) Veena Dua, to be awarded to a meritorious student of M.A. (Sociology) Part-I at the Department of Sociology, University of Delhi, Delhi-110007.

The scholarship to be governed by the following terms and conditions:-

- 1. There shall be one scholarship known as "Veena Dua Memorial Scholar-ship" of the value of Rs.1,200/- per month payable out of the interest accruing from the endowment of Rs.5,00,000(Rupees Five Lacs only) donated to Delhi University by Mrs. V. Saighal.
- 2. The scholarship will be awarded to a student of M.A. (Sociology) Part-I in the Department of Sociology on the basis of the merit. The merit is to be judged on the basis of a scholarship test, performance in the continuous internal evaluation scheme during the first semester and an interview. The test will be conducted by a sub-committee duly set up for the purpose by the departmental staff council. The sub-committee will also evaluate the performance in the "continuous internal evaluation" scheme during the first semester and conduct the interview. The sub-committee will prepare a panel of two names. The scholarship will be awarded to the candidate placed first on the panel, while the second candidate would be kept in reserve.
- The scholarship will be awarded every year and shall be tenable for twelve months covering the duration of the Part\_I course. It shall be renewable in the second year of the course provided the scholar obtains 55% or above marks in the aggregate of the eight papers comprising Part\_I of the M.A. Course.
- 4. If it should appear at any time to the Head of the Department of Sociology that a scholar has failed to make satisfactory progress, or has been guilty of gross misconduct the scholarship may be suspended or withdrawn after due warning in writing.
- 5. No student shall be eligible for this scholarship if she/he already holds a scholarship awarded by Delhi University or any other University or the Central Government or any State Government or a Private Body.
- 6. In case a scholar under this endowment accepts any other scholar-ship/financial assistance from any other source, she/he shall be required to surrender the scholarship and shall also be required to refund the amount received by her/him from the date he/she accepts the other scholarship financial assistance.

- 7. In case a scholar discontinues studies without valid reasons, he/she shall be required to refund the amount received by him/her on account of the scholarship.
- 8. In case a scholarship falls vacant during the pendency of the same, it may be re-awarded for the residuary period to the candidate placed second on the panel.
- 9. Any amount accruing from interest from the endowment and not spent in any year shall be added to the corpus of the endowment fund.
- The payment of the scholarship amount will be made to the scholar through the Head of the Department of Sociology on presentation of a bill and a certificate to the effect that during the period covered in the bill the scholar was not in receipt of any other scholarship or financial assistance from any other source. Further the tutor of the scholar would be required to certify that he/she is regular in attendance and her/his progress in studies is satisfactory.
- 11. A report on the award of the scholarship shall be furnished to the donor each time.
