"PROFESSOR BALVIR & RANJANA SINGH MEMORIAL SCHOLARSHIP"

- 1. There shall be three scholarships called 'Prof. Balvir & Ranjna Singh Memorial Scholarships' of the value of Rs.400/- p.m. each payable out of the interest accruing from the endowment money of 10,000/- Canadian Dollars (converted to Rs.1,07,100/-) donated to Delhi University from the Estate of late Prof. Balvir Singh, who was a Reader in the Department of Economics in this University before joining as a Professor in Concordia University, Canada and perished in a plane tragedy alonghwith his wife and children.
- 2. (a) One scholarship shall be awarded every year to a deserving student of M.A. (Economics) Part-I Course for the duration of the course at Delhi School of Economics. However, the scholarship shall be renewable for the M.A. (Economics) Part-Il Course on satisfactory performance of the awardee and on the recommendation of the Head of the Department of Economics.
 - (b) One scholarship shall be awarded every year to a meritorious student of M.A. Part-II course in Economics enrolled at Delhi School of Economics.
- 3. The scholarships shall be awarded on the recommendations of the Scholarships Committee of the Department of Economics which will follow the same procedure of selection as is followed for the award of other merit scholarships with the Department.
- 4. If it should appear at any time to the Head of the Department of Economics that an awardee has failed to make satisfactory progress or has been guilty of gross misconduct after due warning in writing, his/her scholarship may be suspended or withdrawn on the specific recommendation of the Scholarships Committee of the Department of Economics.
- 5. No student shall be eligible for award of the scholarship under this scheme if he/she already holds a scholarship awarded by Delhi University or any other University or the Central Government or any State Government or a Private Body.
- 6. In case an awardee under this scheme accepts any other scholarship/financial assistance from any other source, he/she shall be required to surrender the scholarship under this scheme and shall be required to refund the amount already received by him/her from the date he/she accept the other scholarship/financial assistance.
- 7. In case an awardee discontinues studies without valid reasons, he/she shall be required to refund the amount received by him/her on account of the scholarship under this scheme.
- 8. In case a scholarship falls vacant during the pendency of the same, it may be reawarded to another student on the recommendations of the Departmental Scholarship Committee for the residuary period.
- 9. Any amount accruing from interest from the endowment and not spent in any year shall be added to the corpus of the endowment fund.
- 10. The payment of the scholarship amount will be made to the awardee through the Head of the Department of Economics on presentation of a bill and a certificate to the effect that during the period covered in the bill, the awardee was not in receipt of any other scholarship or financial assistance from any other source and also that he/she was regular in attendance and his/her progress at studies was satisfactory.
